



## Fireever Pines Photography Mini Sessions

### **Reservations & Booking**

Please contact us directly via email ([info@fireeverpines.com](mailto:info@fireeverpines.com)) or via phone/text @ 804-814-2900. Reservations will start September 30<sup>th</sup> through November 1<sup>st</sup>. We cannot accept any additional bookings after November 1<sup>st</sup> as we'll be beginning to prepare for the upcoming season and beginning to make our wreaths. We only allow (2) photographers on the property at a time to reduce any overlap and allow for maximum exposure to the farm.

Dates available for mini sessions will be as listed below:

Friday, Saturday, & Sundays: November 3<sup>rd</sup> through December 15<sup>th</sup>.

Please note, sessions must be scheduled during our normal operating hours of 9am – 5pm. We will be open to the public during these times as well, however our back field is a bit more secluded and doesn't see much traffic.

### **Rates**

We offer (1) hour sessions for \$50 per hour or a full-day sessions for \$175. No partial hours. Payment is due at the time of booking and once confirmed we'll send a Square invoice for payment. The ***waiver*** and ***proof of insurance*** will need to be provided 48 hours prior to the date of the session. No exemptions.

### **Rescheduling & Cancellations**

Any rescheduling or cancellations must be made 48 hours prior to the scheduled session. This includes changes due to weather, travel, change in circumstances, etc. A full refund will be issued if arrangements are made prior to 48 hours. In the event you need to reschedule, we'll work with you to see if we can make arrangements for a later date based on current availability.

### **Fireever Pines property**

Our first trees were planted in 2018 and we continue to plant more each year. Keep in mind our trees grow approximately 1 ft per year, so currently our tallest trees are ~8-9 ft around the perimeter of the property and 4-5 ft within the interior of the farm. We offer several varieties of trees including White pine, Canaan fir, Concolor fir, Blue spruce, Leyland cypress, and Blue ice. These all have slightly different colors and will make for a great holiday background. Our farm is just over 10 acres and offers great views with a hardwood forest along the northern property line. We also have an old red Dodge pickup truck that looks great in photos!



**Rules & Conditions**

- Please ensure you have booked enough time to allow for walking to the backfields which is roughly a 5–10 minute walk. Ensure you have planned enough time to allow for setup and breakdown.
- You'll be in an outdoor environment on a farm where conditions can change rapidly so, please be prepared. The farm has a variety of terrain including mounds, divots, and overall unevenness so be sure to wear appropriate footwear. Be aware there may be insects, bugs, thorns, mud, and other environmental hazards while traversing the property.
- All props must be taken with you upon leaving. Any items left behind will incur a charge.
- All vehicles must be parked in the parking lot along Jericho Rd. that is defined by the white roping. Vehicles are strictly prohibited from driving through or on the farm anywhere outside of the defined parking lot.
- No vegetation or trees may be pruned, trimmed, or removed while on the property. Any items damaged will be charged full retail price.
- Smoking is not prohibited on the property.
- Pets are welcome as long as they are leashed.
- Please be courteous of our customers and understand we have an active Christmas tree farm with folks looking for Christmas trees.
- We ask if photos are posted online or social media, that the photos are mentioned or shared with Firever Pines.
